## **UNOFFICIAL SUMMARY:**

This letter revises the Annex A, Performance Framework and Summary Budget to the Grant Agreement. The revised Annex A, Performance Framework and Summary Budget are attached.

Dear Mr. Tshiteem,

We are writing this letter to revise the Annex A, Performance Framework and Summary Budget to the Round 7 Malaria Grant Agreement with the revised Annex A, Performance Framework and Summary Budget attached to this letter. These revisions are required to add a condition precedent to disbursement of funds for training purposes and to include the targets for IPVM training for farmers. The targets have been included in the revised Performance Framework in Service Delivery Area (SDA) for Health Systems Strengthening (HSS): Human Resources and HSS: Community Systems Strengthening.

We are also taking this opportunity to update the name and address for notices to the Principal Recipient in Block 13 of the face sheet of the Grant Agreement.

We are modifying the Grant Agreement to reflect the changes described above by:

(1) Updating the following blocks on the Face Sheet:

Revising Annex A to correct the name of the country to "The Kingdom of Bhutan" and (2)to include the following condition precedent:

## "2. Condition(s) Precedent to Disbursement of Grant Funds to Finance Training Activities (Terminal Date as specified in block 7B of the Face Sheet)

The use by the Principal Recipient of Grant funds to finance training programs is subject to the satisfaction of each of the following conditions:

a. the delivery by the Principal Recipient to the Global Fund of the detailed plan and the detailed budget related to the trainings that will be conducted (Detailed Training Plan and Budget). The Detailed Training Plan and Budget must demonstrate that:

there is no duplication of training activities including those i.

funded by other donors and partners;

is a demonstrated need for the training ii. activities including that the trainings activities are linked to the Program Objectives;

there is a method and strategy for selecting training iii. participants, verifying the presence of participants, payment of per diems and ensuring value-for-money;

the quality of trainings will be assessed; and iv.

cash transactions related to the payment of organizational v. costs and per diems are limited whenever possible; and

- b. the written approval by the Global Fund of the Detailed Training Plan and Budget."
- Replacing the attachment to Annex A called "Performance Framework Year 3, 4 and 5 (3)Indicators, Targets, and Periods Covered" with the revised document called "Performance Framework Year 3, 4 and 5a: Indicators, Targets, and Periods Covered" attached to this letter.
- Replacing the attachment to Annex A called "Summary Budget" with the revised (4) "Summary Budget" attached to this letter.

The new face sheet of the Grant Agreement and revised Annex A are also attached.

All other terms and conditions of the Grant Agreement remain the same.

The above changes take effect after you sign this letter. Please confirm your agreement to these amendments by signing the enclosed copies of this letter and returning one copy to us.
