- The main objectives of the meeting were:
 - o Provide an update on membership of the Proposal Development Committee (PDC)

- o Provide an update on the composition of the TWGs for each component (HIV/AIDs, TB, Malaria and Health System Strengthening), clarify the role and finalise the composition of TWGs.
- o Agree on the core writing teams and principal writers for the development for each component of the GF Round 11 proposal.

- ➤ It was agreed that the focal person of the HSS would have a side meeting with the WHO focal person for HSS to discuss and finalise the core writing team for the development of the HSS proposal and the Technical Assistance (TA) needs for this proposal.
- ➤ It was also agreed that all the four programs will include few of the relevant SRs in their TWGs as appropriate.

- The Principal writers have already been nominated to attend the proposal development workshop at WHO SEARO, New Delhi, India, between 8-11 August 2011.
- ➤ It was also suggested that GNHC, PPD, ICB, IHR, DVED, PHL, QSD are needed to be involved in the development of all the proposals and therefore should be consulted by the programs in advance to accordingly utilise their expertise.

5. Selection of Sub Recipients for Round 11

- ➤ It was agreed that the PR will call for expressions of interest (EOI) from the interested Sub Recipients (SRs).
- ➤ It was also agreed that the Proposal Development Committee along with the PR Selection Committee (who on 11 May 2011 at the meeting to evaluate PRs, agreed to work with the PDC on selection of SRs also) will review the EOI submitted and recommend the most appropriate SR to the CCM for endorsement.
- The following timeline for the Round II proposal was agreed upon:
 - 1. The PR will call for EOIs by August 5, 2011. The EOIs will be called for through the website, print and broadcasting media.
 - 2. Interested parties will be asked to register latest by 5:00 PM on August 12, 2011 for an initial briefing and consultative meeting which will be scheduled on August 17, 2011.
 - 3. The purpose this consultative meeting will be to brief interested parties on the GF funded programs and requirements and to familiarise them with the proposal formats in order to apply formally as SRs.
 - 4. Interested parties will be required to submit their EOI proposals to serve as SRs formally by 5:00PM on August 24, 2011.
 - 5. The PDC and the PR Selection Committee will meet either on August 25/26, 2011 to review and propose the most suitable SRs to the CCM.
 - 6. The next CCM meeting is tentatively scheduled on September 6 or 7, 2011 in Thimphu to endorse the SRs. In addition it was proposed that the following proposed agenda items could also be included in the agenda:

- a. Familiarisation of the Round 11 format, requirements and guidelines following the launch of the Round 11 in August 2011 CCM Secretariat
- b. Quarterly progress update of each program All programs.
- c. Presentation of main gaps and priorities for Round II proposals All programs.
- 7. The programs together with the core writing terms and external consultants will work on the component proposals and will present the first outline of the more detailed component proposals to the PDC for a first joint review on September 28, 2011.
- 8. These proposals will be further revised based on the inputs and further refine these following the Regional "mock TRP" which will be held at WHO SEARO during the first week of November
- 9. A further review to finalise these proposals would follow during November, prior to submission of the final proposals to the CCM for endorsement.
- 10. It was agreed that the presentation of the final proposals will be made to the CCM on November 22, 2011 for further inputs/endorsement prior to submission to the Global Fund by December 11, 2011.
- 6. Technical Assistance (TA) for the proposal development for Round 11.
 - ➤ HIV: Since inputs had already been received from the WHO for the development of NSP and operational plan and M&E plans, the program head requested UNAIDS support for one national consultant and one M&E consultant to finalise the M&E plan.
 - TB: TA was requested from WHO for updating the National operational plan, the M&E plan and development of the R 11 proposal.
 - Malaria: TA has already been requested for proposal development and the CVs of two consultants have been received from WHO SERAO.
 - ➤ HSS: The TA needs for the HSS proposal was set aside as it was felt that further in-depth discussions were needed with PPD, PDC and WHO.
 - ➤ The discussion also covered the development of M&E plans, PSM plans, Training plans and Performance frameworks that need to submitted during R 11.
 - ➤ It was agreed that the training plans need to include all the technical assistance for the respective programs through next 5 years.
 - It was noted that the PSM plan of TB for Round 6 Phase II has not yet been approved, as a result of which the procurement as per the work plan has been held up. It was decided that the TB program will communicate with the Global Fund.
 - ➤ It was decided that the CCM Secretariat will lead the writing of section 1-3 of the Round 11 proposal.
- 7. Any other issues:

The CCM Secretariat will check with the members of the PR Selection Committee on their availability to review the SRs together with the PDC committee on 25^{th} or 26^{th} September 2011.
