## **UNOFFICIAL SUMMARY**

This letter approves the Grant Closure Plan, subject to the exceptions and conditions described below. It also sets out the terms and conditions governing the Grant's closure, and the use of Grant funds by the Principal Recipient and its Sub-recipients.

Thank you for submitting your Grant Closure Plan on 30 March 2010. We have reviewed it and would like to inform you that it is approved, subject to the exceptions and conditions described in the table below.

The Grant Closure Date for the Round 4 tuberculosis grant is 31 December 2010. This letter sets out the terms and conditions governing the closure of the grant, and the use of Grant funds by the Principal Recipient and its Sub-recipients.



| 4. | Progress Update and Disbursement Request (PUDR) | The Principal Recipient shall submit a final PUDR and may request funding only for the agreed upon close out activities. Please note that the final PUDR should take into account the cash balance at grant closure (LFA verified to be USD 8,608), and any savings (LFA verified USD 1,563 as per 31 March 2010) resulting from activities listed in the close out plan. |

By signing this letter, the Global Fund and the Principal Recipient agree as follows:

- 1. Gross National Happiness Commission shall implement the activities described in the Grant Closure Plan, in accordance with the Grant Closure Budget, by 31 December 2010.
- 2. No Grant funds are to be spent or committed for expenditure after 31 December 2010.
- 3. The Principal Recipient shall refund to the Global Fund all Grant funds remaining after the completion of the activities described in the Grant Closure Plan (as described in paragraph 8 below).
- 4. The Principal Recipient shall ensure that all of the items provided in the List of Health Products and List of Non-Cash Assets (as included in the Grant Closure Plan) are used, transferred and/or disposed of in accordance with the Grant Closure Plan by 31 December 2010.
- 5. The Principal Recipient shall submit a Final Cash Statement for the Program to the Global Fund by 31 March 2011. The Final Cash Statement must include all Program revenues and expenditures for the period from 1 January 2010 to 31 December 2010. All revenue generated from grant funds (including but not limited to interest, foreign exchange gains, tax refund(s) and revenue from any social marketing activities) must be treated and accounted for as income in the Final Cash Statement.
- 6. The Principal Recipient has submitted to the Global Fund the final Periodic Progress Report for the final period of the Program up to 31 March 2010. In addition, by 31 March 2011, the Principal Recipient shall submit to the Global Fund the Final Grant Report for the period of 31 March 2010 to 31 December 2010.



















- 7. By 30 June 2011, the Principal Recipient shall submit to the Global Fund a Final Audited Financial Report for the period from 31 March 2010 to 31 December 2010.
- 8. The Principal Recipient shall refund any Grant funds that have not been spent in accordance with the Grant Agreement and the terms of this letter by 31 December 2010, as verified by the Local Fund Agent. The refund will be due within thirty days of receiving a request for a refund from the Global Fund. It should be paid into the following account:

- 9. If there is any inconsistency between what is in this letter and what is in the Grant Agreement, the contents of this letter override.


