MINUTES OF THE PROPOSAL DEVELOPMENT COMMITTEE (PDC) MEETING Venue: Mini Conference hall, Ministry of Health Date& Time: 18 Jan 2017;02.00pm to 04.30pm

Subsequent to the receipt of Allocation letter from Ms Lindsey Cole, Fund Portfolio Manager (FPM) on 15 December 2016, the PDC meeting was convened to discuss on the application process for Global Fund grants 2017-2019, with the following **objectives** to:

- To review the GF application process (2017-2019).
- To plan a way forward (timeline).
- TA for proposal development.
- CCM Endorsements and any other issues.

Proceedings: The meeting was chaired by the PDC Chair Dr. Suraj Man Shrestha, Medical Officer, WHO CO.The participants were briefed on the objectives of the meeting. Refer annex 1 for the list of participants and annex 2 for the agenda of the meeting.

Discussions and outcome:

1. <u>Program splits:</u> It was agreed that the three disease programs, with support of the TWGs, will evaluate the program splits on 11 February 2017 and inform the CCM Secretariat/ PDC by 13 February 2017.

The CCM Secretariat was asked to follow up with the FPM for calculation tool used for program spilt and share with the three diseases programs.

FPM informed that in case three Programmes are in disagreement with suggested split a revised plan with justification needs to be submitted within overall ceiling of allocation.

CCM need to submit the signed letter of agreement for programme split suggested by GF along with self-assessment.

It was reiterate by FPM that there is need to allocate sufficient budget for resilience building and health system strengthening under each programme (at least 20% of total budget).

 Program Continuation Request Form: The members together with the programs had anextensive discussion on the Allocation letter sent on 15 December 2016 and the application process. It was agreed that the time duration to submit the Program Continuation Request Form is very limited. During the Skype call discussion with the Ms Lindsey Cole, FPM, it was agreed that Bhutan can request for the extension of submission deadline by 23 May 2017 instead of 20 March 2017.

The CCM Secretariat was asked to write an email to Ms Lindsey Cole, FPM for the above extension of deadline request to submit the Program Continuation Request Form.

It was agreed that the three disease program will submit zero draft of the Program Continuation Request Form by 28th February, 2017.

It was discussed and informed to Fund Portfolio Manager that HIV AIDS programme will adjust the programme strategic support for current and continuous programme under global funds in line with the National Strategic Plan (NSP) 2017-2023 (released on World AIDS Day 2016).

3. <u>TAs for proposal development</u>: It was agreed that the three disease programs will discuss and submit the TOR of TAs for proposal development within two weeks to WHO CO.

<u>Time plan:</u> CCM Secretariat will rework on the grant application work plan in consultation with the FPM and share with the three disease programs. In addition, share the summary timeline for submission of the Program Continuation Request Form and other activity plan discussed and agreed during the meeting at the earliest.

- 4. <u>Pre-requisite conditions for all Global Fund funded procurement related activities:</u> The three disease programs expressed their concern over the Global Fund's pre-requisite conditions for all Global Fund funded procurement related activities to be made from Wambo.org platform (online procurement of pharmaceuticals and health products). It was clarified during the Skype call with FPM that the Wambo.org platform is on trial stage, and the two programs HIV and TB may be exempted from these conditions, but was informed that the Malaria programs are already using the Wambo.org platform, and will be asked to continue the procurement through Wambo.org platform, as it will benefit the program.
- 5. <u>CCM eligibility requirements:</u>CCM Secretariat will update on the CCM eligibility requirements and the status of Performance Assessment (EPA) to the CCM.
- 6. <u>CCM Meeting</u>: The CCM Secretariat will draft an agenda and schedule the CCM meeting two weeks after the submission of the zero draft Program Continuation Request Form.
- <u>FPM Mission visit to Bhutan:</u>Representative from GNHC informed that 15 & 16 March 2017 is the confirmed as the 13th Round Table Meeting. Therefore, it was suggested that Ms Lindsey, FPM can visit Bhutan around this time to discuss with the PDC and the Programs on the Program Continuation Request Form as well as on the steps further on application for Global Fund grants 2017-2019.
- 8. <u>Transition plan:</u> It was agreed that the PDC will review the outcome report and recommendations of the transition meeting held in June 2016 with various stakeholders in Bhutan, which was also attended by the representatives of the GFATM.
